

**Programme Requirements for
Master of Business Administration in Sustainability Transformation (in Chinese)
企業持續發展工商管理碩士（中文）**

1. Entry Requirement

- 1.1 To enter the **Master of Business Administration in Sustainability Transformation** programme, a student shall normally possess:
 - 1.1.1 a recognized degree in a business-related area (or its equivalent), or a qualification equivalent to the HKMU's Postgraduate Certificate in Business Administration (in Chinese); or
 - 1.1.2 a recognised degree in a non-business area (or its equivalent), plus at least three years of recognized supervisory/managerial experience; or
 - 1.1.3 a recognized post-secondary qualification at Level 4 under the Hong Kong Qualifications Framework (or its equivalent), plus at least ten years of supervisory/managerial experience.
- 1.2 To enter the **Master of Business Administration in Sustainability Transformation** programme through Pathway 1, a student shall normally possess:
 - 1.2.1 a recognized Master's degree in a business-related area (or its equivalent).

2 Programme Requirement – Master of Business Administration in Sustainability Transformation (MBASTC)

- 2.1 To be eligible for the award of the degree of Master of Business Administration in Sustainability Transformation, a student shall obtain 36 credit-units and STIP from the following:
 - 2.1.1 6 credit-units of a Compulsory Core Course **MGT 8020BCD** in Table 1;
 - 2.1.2 12 credit-units of a Concentration Core Course **BUS 8061BCD** in Table 1;
 - 2.1.3 **BUS 0089BCD** *Sustainability Transformation Immersion Programme* (STIP) in Table 1; and
 - 2.1.4 18 credit-units of Concentration Elective courses labelled CNE from Table 1.

3 Programme Requirement - Master of Business Administration in Sustainability Transformation (through Pathway 1) (MBASTC1)

- 3.1 To be eligible for the award of the degree of Master of Business Administration in Sustainability Transformation through Pathway 1, a student shall obtain 24 credit-units and STIP from the following:
 - 3.1.1 6 credit-units of a Compulsory Core Course **MGT 8020BED** in Table 1;
 - 3.1.2 12 credit-units of a Concentration Core Course **BUS 8061BED** in Table 1;
 - 3.1.3 **STIP 802BCD** *Sustainability Transformation Immersion Programme* (STIP) in Table 1; and
 - 3.1.4 6 credit-units of a Concentration Elective Course labelled CNE from Table 1.
