

## Programme Requirements for Master of Social Sciences/ Master of Social Sciences (with specialization in Applied Economics and Policy Analysis/ Applied Psychology/ Criminology and Social Policy Studies/ Global Governance)

## 1. Perioid of Study and Entry Requirement

1.1 A student must complete the Master of Social Sciences or Master of Social Sciences (with specialization in Applied Economics and Policy Analysis/ Applied Psychology/ Criminology and Social Policy Studies/ Global Governance) programme within the prescribed periods as stipulated below:

Normative Period of Study	Maximum Period of Study*
1 year (full-time)	3 years (full-time)
2 years (part-time)	4 years (part-time)

\*The maximum period of study shall include any periods of leave of absence and deferment of studies.

- 1.2 To enter the Master of Social Sciences or Master of Social Sciences (with specialization in Applied Economics and Policy Analysis/ Applied Psychology/ Criminology and Social Policy Studies/ Global Governance) programme, a student should:
  - 1.2.1 hold a Bachelor's degree from a recognized tertiary education institution, or equivalent; and
  - 1.2.2 satisfy the University English language proficiency requirements.

## 2. Programme Requirement - Master of Social Sciences (MSSCF)

- 2.1 To be eligible for the award of the degree of **Master of Social Sciences**, a student shall:
  - 2.1.1 obtain 30 credit-units as prescribed below:
    - 2.1.1.1 12 credit-units from all compulsory courses labelled CA in Table 1;
    - 2.1.1.2 18 credit-units from any specialization courses labelled AE/AP/CS/GG in Table 1;

and

- 2.1.2 attain the CGPA for graduation as prescribed in the Regulations for the Award of Postgraduate Degrees.
- **3.** Programme Requirement Master of Social Sciences (with specialization in Applied Economics and Policy Analysis) (MSSCAEPAF)
  - 3.1 To be eligible for the award of the degree of Master of Social Sciences (with specialization in Applied Economics and Policy Analysis), a student shall:
    - 3.1.1 obtain 30 credit-units as prescribed below:



- 3.1.1.1 12 credit-units from all compulsory courses labelled CA in Table 1;
- 3.1.1.2 18 credit-units from the Applied Economics and Policy Analysis specialization courses labelled AE in Table 1.

and

- 3.1.2 attain the CGPA for graduation as prescribed in the Regulations for the Award of Postgraduate Degrees.
- 4. Programme Requirement Master of Social Sciences (with specialization in Applied Psychology) (MSSCAPF)
  - 4.1 To be eligible for the award of the degree of Master of Social Sciences (with specialization in Applied Psychology), a student shall:
    - 4.1.1 obtain 30 credit-units as prescribed below:
      - 4.1.1.1 12 credit-units from all compulsory courses labelled CA in Table 1;
      - 4.1.1.2 18 credit-units from the Applied Psychology specialization courses labelled AP in Table 1;

and

- 4.1.2 attain the CGPA for graduation as prescribed in the Regulations for the Award of Postgraduate Degrees.
- 5. Programme Requirement Master of Social Sciences (with specialization in Criminology and Social Policy Studies) (MSSCCMSPSF)
  - 5.1 To be eligible for the award of the degree of Master of Social Sciences (with specialization in Criminology and Social Policy Studies), a student shall:
    - 5.1.1 obtain 30 credit-units as prescribed below:
      - 5.1.1.1 12 credit-units from all compulsory courses labelled CA in Table 1;
      - 5.1.1.2 18 credit-units from the Criminology and Social Policy Studies Specialization courses labelled CS in Table 1;

and

- 5.1.2 attain the CGPA for graduation as prescribed in the Regulations for the Award of Postgraduate Degrees.
- 6. Programme Requirement Master of Social Sciences (with specialization in Global Governance) (MSSCGGSF)
  - 6.1 To be eligible for the award of the degree of Master of Social Sciences (with specialization in Global Governance), a student shall:
    - 6.1.1 obtain 30 credit-units as prescribed below:
      - 6.1.1.1 12 credit-units from all compulsory courses labelled CA in Table 1;



6.1.1.2 18 credit-units from the Global Governance specialization courses labelled GG in Table 1;

and

6.1.2 attain the CGPA for graduation as prescribed in the Regulations for the Award of Postgraduate Degrees.
